(Flesch Readability Score: 81.4). *[Digest: The Act tells BOLI to study matters related to the laws that BOLI enforces. A report will be submitted by September 15 of next year. (Flesch Readability Score: 65.5).] [Requires the Bureau of Labor and Industries to study matters relating to laws over which the bureau has enforcement authority. Directs the bureau to submit findings to the interim committees of the Legislative Assembly related to business and labor not later than September 15, 2026.] [Sunsets on January 2, 2027.]* **Establishes the Employer Assistance Division within the Bureau of Labor and Industries.
